A LAITY-LED MISSION OF GRATITUDE IN ACTION

133 years ago, a group of laypeople came together out of concern over what would happen to their ministers when they retired. The sad reality is that a life of service, though a noble choice, often poses undue financial worry on those who choose that path. These laypeople recognized that reality and created the Laymen's Relief Association, which would become known as the Conference Claimants' Endowment Board.



What began as grassroots effort focused primarily on retirement funding, has evolved into a century-long legacy of supporting retired clergy and their spouses across the California-Nevada Annual Conference. Endowment Board support includes pension contributions, healthcare cost assistance, fellowship, and relational care. Thank you, for walking with us and entrusting us to be good stewards of your funds. Our greatest joy is gifting our retired clergy and their spouses funds to help ease their retirement financial burdens. We can only do it with your support.

TEAMWORK MAKES THE DREAM WORK

The Endowment Board (EB), the Retired Clergy Association (RCA), and the Conference Board of Pensions (CBOP) collaborate all year long to discuss where more assistance is needed to address modern challenges that the retired clergy and spouses may be facing. On Valentine's Day, the Executive Committees of all three agencies held a special meeting to identify changing needs and inflation driven increased costs of living. Excellent ideas were exchanged and a path to action was forged.



The Endowment Board, the Conference Board of Pensions, and the Retired Clergy Association's Executive Committees met in Stockton to discuss strategic planning in February 2024.

As a result, The Endowment Board's Board of Trustees unanimously approved an increase of \$30,000 to our annual Retired Clergy Association grant, bringing the 2024 gift total to \$136,000. We are blessed to provide the additional funds which will ensure more programming, event attendance support, and no-cost administrative fees which will ease the pain of inflation for our retirees. Endowment Board President, Ms. Mary Popish, formally presented the grant to the Retired Clergy Association as well as the \$2M annual grant to the Conference Board of Pensions on Sunday, June 9th at Annual Conference Session (pictured). That is a grant total of \$2,136,000 for 2024.


General Healthcare Fund

When you make a donation to The Endowment Board, you have three funds you may choose to direct your gift towards - the **Shepherd Fund**, the **Healthcare Premium** Assistance Fund (formerly the Healthcare Subsidy Fund), or the General Healthcare Fund.


The Shepherd Fund offsets costs for retired clergy and spouses in times of need. The fund has provided cost assistance for a lost hearing aid, relocation to an assisted living situation, a personal financial emergency, and a case of identity theft. Asking for help can be difficult for those who have chosen a life of service and selflessness, but the hope is that those who qualify will see the Fund as a blessing. The fund is confidentially administered by the Conference Board of Pensions office.

The Healthcare Premium Assistance Fund was established to provide support for those in difficult situations who may not be able to afford their healthcare premiums.


The General Healthcare Fund is used to help fund the \$2M annual grant to the Conference Board of Pensions.

LEAVING A LEGACY GRATITUDE IN ACTION

Legacy giving, also known as planned giving or deferred giving, allows you to achieve your personal, financial, and philanthropic goals, and make a larger gift to a charity than you could make from ordinary income. Common types of planned gifts include charitable bequests, IRA charitable rollovers, charitable remainder trusts, retirement assets, pooled income fund contributions, and blended gifts.

THE ENDOWMENT BOARD'S POOLED INCOME FUND

INCOME FOR LIFE WITH A PHILANTHROPIC TWIST

The Endowment Board's Pooled Income Fund (PIF) is a separate charitable trust fund managed by estate planning attorneys at Hobson and Hobson. When people generously contribute to our PIF, they receive income for life and tax benefits.

THE PIF WORKS AS FOLLOWS:

- Contributions are pooled with those of other donors and invested in our fund.
- Income is paid quarterly based on interest in the fund.
- Upon passing, the remaining principle is transferred to The Endowment Board.

In 2023, our PIF participants received a 5.9%* average rate of return

It was with his guidance that we revived our fund development program in 2015 which he believed in so much that he and his wife, Vicky, became inaugural members of our Pooled Income Fund. We were blessed to have known him and the infinite wisdom that he imparted.

In the 2023/2024 fiscal year, The Endowment Board, along with Moraga Valley Presbyterian Church Foundation, was a beneficiary and trustee of a Charitable Remainder Unitrust established in 1994 by William and Elaine Halliday. The trust generated income for William and Elaine during their lifetimes, and upon their deaths, the remainder was transferred to the designated beneficiaries (over \$83,000 for The Endowment Board) – a win-win for the donor(s) and the charities. The Endowment Board strongly believes in doing good for the whole, so we will always encourage our donors to name multiple beneficiaries should their heart be called to do so.

Qualified Charitable Distribution: A Tax-Smart Strategy for Charitable Giving with an IRA

If you are at least 70 ½ there is a great benefit available to you for your charitable giving. With the increased standard deduction, fewer people can itemize which means your charitable giving isn't reducing your tax burden.

Instead, there is a program called "Qualified Charitable Distribution" or QCD. Through this program, you can designate a charity like The Endowment Board or your local church to receive a portion of your traditional IRA account. It can count as part of your RMD (Required Minimum Distribution) but when you file your tax return, you reduce the taxable IRA amount by this contribution putting the code "QCD" next to the taxable IRA amount. Most online tax programs are now set up to ask if any of the IRA was distributed to a charity. This is available for distributions up to \$105,000 per year. Since it reduces your Adjusted Gross Income, it can reduce how much of your Social Security is taxable. Most financial advisors are familiar with this program and can help you take advantage of this tax break.


